



# HR Issues During COVID-19

Global survey by CT Executive Search in partnership with the Belgian-Luxembourg Chamber of Commerce








- This was a two week global survey carried out in May, 2020, with participants from 10 countries.
- The majority of the respondents were business owners, general managers and managers between the ages of 35 and 44.
- Close to 70% of the respondents said that there have been no terminations during COVID-19.
- Over 60% of the respondents indicated that there were no salary cutbacks.
- Over 87% of the respondents said that there are currently employees working remotely, and over 10% said that those working remotely will not be returning to the office after the lockdown regime is over.






#### Q 1: GENDER



## Q 4: WHICH OF THE FOLLOWING CATEGORIES BEST DESCRIBES YOUR EMPLOYMENT STATUS?










#### Q 5: WHAT INDUSTRY/SECTOR DO YOU SPECIALIZE IN?





#### Q 6: HAVE THERE BEEN ANY TERMINATIONS IN YOUR COMPANY?



#### Q 7: IF YES, WHAT WAS THEIR SENIORITY LEVEL?










#### Q 8: HAVE THERE BEEN SALARY CUTBACKS?










### Q 9: ARE SOME OF THE EMPLOYEES AT YOUR COMPANY WORKING REMOTELY?




